TERMS AND CONDITIONS

- Minimum opening order for program status is 96-pockets for Avanti, A*Press and America everyday product. Minimum opening order for program status for NIQUEA.D is 84-pockets everyday product.
- 2. Program customers must maintain cards year-round to retain their benefits:
 - Service from an Avanti sales representative as needed
 - Exchanges on unsold product (see #3 below)
 - A free display (see Display Terms)
 - Free shipping on card orders over \$150 (if under \$14.95 s&h)
- 3. Exchange privileges are for program customers only. Exchanges are approved at the discretion of Avanti, and must always be accompanied by a reorder of greater value. Exchanged products must be returned to Avanti at the retailer's expense and are subject to deadlines. Exchanges are issued as credit toward card purchases only NO REFUNDS WILL BE GIVEN.
- 4. Program benefits are contingent upon timely payments of Avanti Press invoices.
- 5. Avanti Press, Inc. retains open to buy status with all program customers.
- Program customers will have their card assortment placed on a pocket control system to optimize retail performance.
- 7. Avanti Press, Inc. reserves the right to:
 - a. Adjust product prices
 - b. Require COD shipment terms (if considered necessary)
 - c. Cancel or modify this agreement, by written notice to the retailer.

I agree that Avanti may charge up to the legally allowable rate of interest on delinquent accounts. If collection is necessary, my company will be held responsible for all costs incurred. 1.5% per month interest may be charged on delinquent invoices.
